QUICK PAY SERVICES**

- Bidcoin LLC must be made aware of Quick Pay request at time of booking a load
- Submit one email for each load - do not combine two or more loads on one email or it may cause a delay in paperwork and payment processing.
- Ensure all copies of images are clear and attached to the email
- Include signed copies of the Bidcoin LLC Rate Confirmation and signed B.O.L. and any other necessary documentation
- Please make sure total attachments size is less than 20 MB

Bidcoin LLC does not offer a fuel advance

When do I get paid? All properly submitted invoices are processed within two business days of receipt- Monday-Friday 8am-4PM CST, and will be released for payment. Incomplete paperwork may delay this timeline and disqualify a payment from the Quick Pay Service.



- Submitting legible paperwork. Our accounting department is available from 7 A.M. until 4 P.M. CST and paperwork is officially received only during those hours. Anything received after 12:00 noon (CST) will fall into the following business day.
- Receiving Payment. Once Bidcoin LLC has released funds to your bank, based on the guidelines above, each bank has their own processing procedure as to when the funds will be available in your account. In general funds are usually received the following business day. Please consult with your financial institution for further information regarding electronic deposits.

**Quick Pay Agreement**

("Carrier") hereby grants Bidcoin LLC ("Broker") the right to deduct 5% from the invoice presented under this agreement with the understanding that Broker will release payment of that item within two (2) business days based on guidelines of receipt times outlined in the Quick Pay Services detail. Carrier acknowledges that all legible documents are required before processing timeline can begin. Bidcoin LLC reserves the right to refuse Quick Pay Services if deemed necessary and any invoices would be paid on regular terms at normal rates. Qualifying events would include but not limited to: incomplete paperwork, illegible documents, additional audit/validation of the load, invoice amount not matching signed rate confirmation. In the event an invoice needs additional timeline for review the discount and quick pay of an invoice may be removed and paid on regular terms. Carrier may terminate this Quick Pay Agreement by notifying Broker in writing. Any terminations will take effect immediately upon receipt of notice. Broker reserves the right to terminate this Quick Pay agreement without notice. Termination of this Quick Pay agreement would constitute a return to the original payment terms as specified in the original agreement.
